Board Member Eckstein recommended a room/area in the Airport be named in honor of John "Jack" F. Bolt (Sanford resident); the first (and only) U.S. Marine jet fighter ace, who served during World War II and the Korean War. He is the only U.S. Marine to achieve ace status in two (2) wars.

Board Member Eckstein questioned if there has been any effect on TBI's operations as a result of the strengthening of the dollar. Mr. Gouldthorpe noted they have not noticed anything yet; the summer tour packages will be on the market at the World Travel Market in London and will start selling as early as November.

In order to attract British visitors to the local area, Board Member Robinson suggested offering them packages to the local attractions. Vice Chairman loppolo questioned the status of attracting new international airlines. Mr. Gouldthorpe noted staff attended the World Routes Conference in Chicago and met with nineteen (19) airlines, many of them international carriers. President Dale stated that GOAA just passed an incentive plan, and that many other international airports are doing it as well. He noted that if the Authority does not "get on board with it", going to these type of conferences is going to be a waste to time. He would like to bring forward to the Board at the November meeting an overview of what the incentive plan might entail. Discussion ensued regarding incentive programs, funding, and expansion.

15. <u>COMMENTS FROM THE PUBLIC</u>

Bob Turk distributed various advertising/marketing materials, and noted the City is trying to do more advertising and marketing. He also stated the City is entering into a contract to do a new city-wide economic development plan, in an effort to further develop Sanford.

As requested by Board Member Eckstein, Kevin Spolski distributed sketches he created showing possible future development/improvements of Mellonville Avenue, in order to make it more attractive for prospective tenants.

16. OTHER BUSINESS

Regarding the SR 46 Expansion Project, Board Member Miller expressed frustration over the surcharge issue, and suggested the Board, by consensus, support (authorize)

President Dale to communicate to FDOT the Board's concerns over this matter. Mr. Spolski noted that no one has addressed the FDOT regarding the 14-month delay issue, and stressed it needs to be challenged because they could be wrong. Discussion ensued regarding the feasibility of beginning construction on the east end of the project (SR 415) concurrent with the surcharging on the west end (Mellonville Avenue) that is scheduled to begin January 2015. Following discussion, it was the consensus of the Board for President Dale to use all means and avenues available to move forward in presenting the FDOT with the Board's alternate suggestion.

Board Member Slattery questioned the status of the request for a new facility, made by Gator Dock & Marine at the previous Board meeting. President Dale stated the meeting with the tenant had to be rescheduled, and staff is still awaiting confirmation for the new date/time. Board Member Slattery said he spoke with the Authority's bank and was told they would fully underwrite the tenant and their ability to sustain a long-term lease with the Authority.
