#### 3. AGENDA ITEMS

A. Consider approval of Lease No. 2010-16 with CITY OF SANFORD for Building 132, located at 2805 Carrier Avenue, and the small garage located immediately south of Building 310, located at 1345 E. 28<sup>th</sup> Street.

Consider approval of Lease No. 2010-16 with CITY OF SANFORD for Building 132, located at 2805 Carrier Avenue, and the garage located immediately south of Building 310, located at 1345 E. 28<sup>th</sup> Street (office).

The lease shall have a one (1) year term, commencing on July 1, 2010. The lease consists of 2,152 square feet of office space at \$5.00 per square foot. Note: There is no charge for the garage. The annual rental rate is \$10,760.00 the first year; the monthly payment is \$896.67. The building will be used by Seminole Youthbuild, Inc. for a community improvement program for disadvantaged youth.

NOTE: This lease was approved by the City Commission on June 21, 2010.

CPH ENGINEERS, INC. has submitted Task Order No. 5 to provide professional engineering services for the design of Runway 9L-27R and Taxiway "B" Extension.

The lump sum cost of this task order is \$1,214,958.00, comprised of the following fee split:

C. Consider authorization of Chairman to execute the General Release between the Seminole County Sheriff's Office and Hunt Insurance Group, LLC, AND the Sanford Airport Authority and SAPD Officer Joseph E. Goslin.

Consider approval to authorize Chairman to execute the General Release between the Seminole County Sheriff's Office and Hunt Insurance Group, LLC, AND the Sanford Airport Authority and SAPD Officer Joseph E. Goslin.

#### BACKGROUND:

- On December 28, 2009, SAPD Officer Joe Goslin was bitten on the right forearm by a dog that belongs to the Seminole County Sheriff's Office.
   Officer Goslin was at the Vehicle Inspection Station drying his vehicle with a towel. Evidently, a Seminole County Sheriff's canine officer was nearby with his dog, which was not restrained and attacked Officer Goslin.
- Officer Goslin was taken to South Seminole Hospital for treatment and a first report of injury was filed with the Airport's worker's compensation carrier, PGIT.
- Larry Dale spoke to Chief Deputy Steve Harriett about the incident and was advised that the Sheriff's Office would assume liability for the incident.
- Officer Goslin developed complications and had to return to South Seminole Hospital and CentraCare numerous times for treatment between December 28, 2009 and February 1, 2010.
- The total amount paid by SAA was \$ 7,510.83 and was billed to the Sheriff's Office for reimbursement.
- The Sheriff's Office is ready to remit payment provided the SAA and Officer Goslin sign a General Release.
- The worker's compensation carrier, PGIT, advised "As long as the medical records don't indicate any additional treatment and he was placed at MMI and he has been working without any issues, then you can go ahead with the release".
- The SAA decided to bill PGIT for the expenses and have PGIT contact the Sheriff's Office for reimbursement, and submitted all documentation and invoices to PGIT, per their request. PGIT has now said they would prefer that the SAA seek reimbursement directly from the Sheriff's Office. According to PGIT, if Officer Goslin has any related problems in the future, PGIT would reopen the claim and pay accordingly for his expenses.

Staff recommends authorization of Chairman to execute the General Release between the Seminole County Sheriff's Office and Hunt Insurance Group, LLC, AND the Sanford Airport Authority and SAPD Officer Joseph E. Goslin.

Motion by Board Member Donihi, seconded by Board Member Cattell, to approve Agenda Item C, subject to Officer Goslin signing the release and letter from Counsel

stating the Authority would cover any future problems under the Worker's Compensation law. Motion passed.

D. Review of Draft SAA Budget FY 2010-2011.

President Dale, CEO, and Staff, briefed the Board on the Airport Authority Fiscal Year 2010-2011 Proposed Operating and Capital Budget.

Discussion ensued.

Board Member Cattell requested a matrix for the customer facility charges, public safety fees, landing fees, and passenger facilities charges.

Board Member Miller requested a salary matrix for the positions making less than \$10.00 an hour.

It was the consensus of the Board to review both matrices on the next meeting.

Based on the calculations, Chairman Longstaff would then meet with President Dale to discuss the terms of the contract.
