Joint Meeting

1. CALL TO ORDER

The joint meeting was called to order at 4:00 p.m. by Mayor Kuhn. She announced this was a public meeting and that it was properly advertised. Mayor Kuhn turned over the floor to Vice Chairman Donihi.

The SAA Board meeting was called to order at 4:01 p.m. by Vice Chairman Donihi.

3. ANNUAL BUDGET FISCAL YEAR 2010-2011

President Dale discussed the Annual Budget for Fiscal Year 2010-2011.

Staff recommends approval by SAA Board of SAA Comprehensive Annual Budget Fiscal Year 2010-2011 [October 1, 2010 – September 30, 2011].

President Dale briefed Commissioner Woodruff on the Airport Law Enforcement Training Range at Silo Point. The range will be used by airport personnel (police and wildlife officers) to train for coordination, and could be used for public demonstration events (ex: Leadership Seminole) under the supervision of an Airport certified safety officer.

Commissioner Mahany congratulated President Dale on receiving the 2010 Aviation Professional of the Year award, and requested an update on the cellphone parking lot. President Dale clarified it is being used; however, paving must wait until the Ventura renovation is complete and the plane is installed.

Commissioner Mahany questioned what the \$30,000.00 for professional fees was for. Bryant Garrett clarified that it was for METROPLAN ORLANDO.

Commissioner Mahany asked for clarification about a statement made during a meeting in regards to transportation of passengers to area malls. President Dale stated that the Airport had two Lynx buses, and shuttles transport passengers from/to the parking/terminal. Bryant Garrett clarified that in 1996 OSI used to transport passengers to Seminole Town Center.

President Dale stated the award he received belongs to the City and SAA staff as well. He is proud of the staff, the City, and the County for their support.

Commissioner Woodruff stated he would like to see some sort of signage at the Airport Blvd. entrance. President Dale stated he would like to work with the City again, and asked Tom George to assign somebody to this project.

Mayor Kuhn asked if there were any comments from the public. Mark McCarthy noted worker's compensation had decreased, and asked President Dale how was it done. President Dale clarified employees attend mandatory safety meetings to reduce risk.

Motion by Board Member Cattell, seconded by Board Member Litton, to approve the SAA Comprehensive Annual Budget Fiscal Year 2010-2011. Motion passed unanimously.

Vice Chairman Donihi turned over the floor to Mayor Kuhn.


