A. Consider Approval of Sanford Airport Authority Board of SAA Comprehensive Annual Budget Fiscal Year 2021-2022 (October 1, 2021- September 30, 2022).

Current Year Successes

President Nolan referenced the Annual Budget Fiscal Year 2021-2022 Presentation on the wall screen. Highlighted current year successes, SFB Airport is recovering at a robust pace trending upward, remaining cautiously optimistic. Transition of President and new CFO, recruitment process for new VP of Development, competition of Terminal Expansion. Air Service Development program being advanced with two new airlines Flair & Swoop both Canadian Airlines. Retired all outstanding FDOT loans. Completed design of Customs and Border Protection 60,000 sq.ft. space renovation we are mandated to remodel \$20M project. Airports first ever program procurement department. First highly successful air show with over 25,000 attendees. On September 14th in City of Sanford Council Chambers, public workshop will be held as FAA requires for the SFB updated Master Plan.

Budget Summary

Jason Watkins, CFO referenced the presentation on the wall screen and provided a Budget Summary net operating budget surplus \$3.2M. CARES reimbursement \$10M, ARPA funding allocation was appropriated after our Board approved the budget \$12.5M working on highest best way to use those funds not factored in to this Budget.

Recovery

Passenger standpoint modeled on FY 2019 the year prior to COVID, international travel slower this budget modeled at 75% passenger level. Capital FIS station makes up 2/3. Passenger trends chart enplanements, July 86% same period two years ago. A lot of unknows with Delta Variant and airlines seeing effect through bookings, a delayed reaction. Presented a conservative revenue picture believe budget will withstand variation in passenger levels.

Budgeted Operating Expenses

Salary & Benefits two thirds of the operating expenses at the Authority, what is driving the increases: 12% budgetary increase in health insurance, adding seven new positions in areas identified as critical needs, vacancies year over year, workers comp increases, 4% cost of living increase. Marketing & Advertising added local airline origination marketing, airports are aggressive generate new service market share.

Mayor Woodruff thanked Board Director Smith; this is his last meeting he terms out. Mayor Woodruff noted Board Director Smith has put a lot into what goes on at the Airport, especially the Terminal Expansion project and it is appreciated.
