Notice is hereby given that the regular meeting will adjourn to conduct a First Executive Session pursuant to Florida Statute §286.011(8) so that the Authority may discuss *Sanford Airport Authority v. TBI US Operations, Inc.*, Case No. 2024-CA-001039, currently pending in the Circuit Court of the Eighteenth judicial circuit in and for Seminole County, Florida. The length of the First Executive Session is estimated to be approximately thirty (30) minutes.

Notice is hereby given that the regular meeting will adjourn to conduct a Second Executive Session pursuant to Florida Statute §286.011(8) so that the Authority may discuss *Sanford Airport Authority v. Orlando Sanford International, Inc.*, Case No. 2024-CA-001044, consolidated with *Orlando Sanford International, Inc. v. Sanford Airport Authority*, Case No. 2024-CA-000420, both currently pending in the Circuit Court of the Eighteenth judicial circuit in and for Seminole County, Florida. Please take notice that if any person decides to appeal any decision made by the Sanford Airport Authority with respect to any matter considered at the meeting or hearing scheduled herein, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based, per Section 286.0105, Florida Statutes.
