**The following Notice/Meeting/Solicitation has been cancelled:**

The Sanford Airport Authority, hereinafter called "Owner," hereby requests sealed bids for the **"OVERHEAD DIGITAL SIGNAGE SYSTEM – PHASE 1 (RE-BID)" (Project), at ORLANDO SANFORD INTERNATIONAL AIRPORT (SFB).**

**The project can generally be described as:**

SFB, a growing small hub airport, seeks to replace its four (4) existing Daktronics GP4-180x180-20-SF arrival/departure overhead digital signs with a new, high-performance outdoor digital signage solution. This solution will include the displays, supporting hardware, and a robust Digital Signage Content Management System (DSCMS). Future Phase 2 expansion will integrate with the DSCMS implemented in Phase 1, including the addition of new signage and replacement of existing static signage.

~~Electronic Sealed Bids will be accepted on the Sanford Airport Authority's online procurement webpage up to 2:00 pm, local time, August 20, 2025,~~ at which time all bids received will be publicly opened, the contents noted and read aloud. The failure to comply with any requirement contained in the Bid Documents may result in the rejection of the Bid as non-responsive or a finding that the Bidder is not qualified for this Project.

~~A NON-MANDATORY Pre-Bid Conference will be conducted at the Orlando Sanford International Airport, Sanford Airport Authority Vigilante Room, 2001 Red Cleveland Boulevard, Sanford, Florida 32773 on July 31, 2025, at 10:00 am, local time.~~ The Pre-Bid Conference is the primary opportunity that Bidders will have to address with the Owner questions about the Project, the Contract Documents, and the Owner's security requirements.

A Bid Security in the amount of five percent (5%) of the sum of the Total Bid Price will be required for this Project. Exact Bid Guarantee period requirements are defined in the Special Terms and Conditions in the project on the Authority procurement portal OpenGov.
